- 4. Latest Presidential Decree (DNU). Licensees' new obligations and rights. Note: Could entail new regulations on fair trade Possible speaker: TBD
- 5. Registration of agreements with the TMO. Proceedings. Best practices. Possible speakers: Pablo Ancarola and Rosana Bardi.
- 6. Licensing fiscal structures. Possible speakers: TBD
- 7. Retail business: TODO MODA/ ISADORA. Sharing the experience of its business structure and growth.

8. The new Civil and Commercial Code and franchise agreement. How do the new rules impact on license agreements?
