2 November 2020

LES Russia, with the support of the Russian State University of Justice and the World Intellectual Property Organization (WIPO), held an online seminar "Protection of Intellectual Rights in the Digital Transformation of the Economy".

Among the topics discussed: digital economy and IP: what problems arise in IP management in the digital economy; WIPO approaches to issues of digitalization of society; specifics of consideration of cases in the field of intellectual property and digital technologies in various jurisdictions; the concept of digital rights and their negotiability; protection of copyright and related rights in the digital environment; protection of exclusive rights to computer programs and many others.

The seminar was of great interest to the audience and gathered over 100 people.

15 October 2020 - 20 October 2020

LES Russia held an online session "Digital Technologies in Intellectual Property" at the LES Annual Meeting 2020.

Among the topics discussed: the innovative digital technologies and services provided by the Russian PTO; use of blockchain technology by public authorities and the private business; use of Artificial Intelligence for patent examination and search; 3D models - new digital tool to different kinds of IP were in the focus of the discussion.

18 June 2020

ES Russia in cooperation with ICC Russia and Gorodissky & Partners firm held the webinar "Venture Capital: How to Build a Business on Intellectual Property".

LES Russia members spoke at the seminar: Veronika Fridman, Ph.D., Counsel with Gowling WLG gave presentation "The Role of Intellectual Property in Creating Startups and Joint Ventures"; Sergey Medvedev, Ph.D., LL.M., Partner, and Sergey Vasiliev, Ph.D., Partner (both from Gorodissky & Partners, Moscow) gave presentations on "Securing financial transactions with a pledge of intellectual property" and "Intellectual Assets Audit: Methods and Recommendations" respectively.

The webinar was moderated by professorNatalia Karpova, Ph.D., Chair in RANEPA under the President of the Russian Federation, Vice President of LES Russia.

The webinar aroused keen interest and attracted an impressive audience.

27 May 2020

Sergey Dorofeev, President of LES Russia, took part in the National Presidents' Council Meeting.

20 May 2020

Sergey Dorofeev, current LES-Russia President is elected to serve VP (vice president) of Licensing Executives Society International (LESI) and a Board liaison for the Meeting Committee, Patents & Technology Licensing Committee and YMC (Young Members Congress) for 2020-2021.

Sergey Dorofeev, President of LES Russia took part at the Virtual Toast to World IP Day of the LES International members. About 200 people, 85 % of them are the members of LES joined the virtual toast.
