Mitra-Ventanilla together with LES Philippines hosted the Asia Pacific leg of YMC with three different sessions: "Session 1 - Let's Journey Together: Stories of Young Professionals" looked into young professionals' everyday concerns, how they are overcoming challenges in their personal and professional lives, and how they are coping with the new normal; "Session 2 - Building a Legacy from Innovation" highlighted Filipino Tech CEO Bobby Ocampo's success story in Silicon Valley; and "Session 3 - Recent Issues in Copyright Licensing" discussed the current issues in copyright licensing encountered by artists, music professionals, and social media personalities and focused on trends, and future direction of copyright licensing in light of the on-going pandemic.
