1. CHAIR AND SECRETARY OF THE MEETING

3. OVERVIEW OF THE VOTES TO BE TAKEN

Dana Colarulli ("Dana") informed the meeting participants on the running of the meeting and the votes to be taken, including the minutes from the 2022 IMDM, Awards, and 2023-2024 Board Slate.

4. APPROVAL AND WAIVER OF READING OF THE MINUTES OF THE LAST IMDM

Tatiana called for a vote which was passed by the delegates.

the reading of and to ratify the minutes of the International Management and
Delegates Meeting held on May 8, 2022 in Venice, Italy.

5. PRESIDENT'S REPORT

Ichiro presented his outgoing president's report which referenced the submissions, numbers and challenges LESI has gone throughout the year. He highlighted the importance of communication and transparency and approached the following topics:

- Issues addressed in light of the LESI By-laws (including resolving issues related to the creation of the non-executive directors)

- Mitigating risk with the LESI Annual meeting (including his conversations with INTA)
- o Unresolved issues

He ended his remarks thanking LESI, Past Presidents, Committee Leaders, National Presidents and Leaders, Organizing Committee members, Administration members and Board Members.

6. EXECUTIVE DIRECTOR'S REPORT

Dana first asked all the new delegates to stand and identify themselves and thanked them for attending. He briefly ran through some LESI history, noting that it was a significant milestone year for the organization. In 1973, 50 years ago, the international organization was officially born through the work of a number of professionals including Marcus Finnegan, from the Finnegan Law Firm, who chaired the committee proposing the organization and the initial by-laws.

He showed a picture of the initial Board of Directors and said that the mission of the organization today is still just as important as it was at that time – to professionals at various stages in their careers. He said that the core goals 50 years ago – build an organization to create opportunities for networking and to develop stronger relationships, with professionals throughout the world that understand and can provide insight into why industries are changing what that means. He said that it was critical to differentiate the work that LESI does from other organizations. He quoted Past President Arnaud Michael who said that LESI conversations focus on "real life" – in other words, the practical side of

effectively using IP; to leveraging and monetizing IP to brings new technology into the world that would not have otherwise existed.

He quoted LESI Past-President John Paul described LESI as a "community of communities" noting that was often those smaller communities within LES that were the most valuable to our members and the need to enable those smaller communities to flourish as we, at the same time, try to grow the global organization.

He provided a short overview of the IMDM agenda including the budget report from Sonja London, and remarks from Mike Lasinski on his priorities in order to grow a sustainable organization. He noted that great program and speakers to come during the conference during the next two days and LESI had drawn more than 500 people to Montreal. He thanked the delegates for leading many of the conversations in the program and workshops and for drawing more people into the organization.

Sonja London ("Sonja") provided a budget report and the financial outlook for LESI for 2023 and 2024. Including information about LESI Financial Trends 2017-2023; Current Financial Position; Budget for 2023 and offered a Proposal for Sustainable Financial Position for LESI & LES Member Societies.

16. INCOMING PRESIDENT'S REPORT

Michael Lasinski ("Mike") provided a short background of how he joined LES in the mid-90's and eventually served on the LES USA & Canada Board of Directors. He said that when he was asked to be treasurer of LESI, he was told that he would just need to look to passing a dues increase and putting an investment policy in place. He joked that he was not warned about the global pandemic or about shutting down Berlin when he accepted the position.

He then ran through his slides detailing out his priorities for 2023-2024 and the LESI Board Members and other volunteers that would lead these efforts. He noted that he had asked the incoming board members to take on one of more specific areas to help implement a focused Agenda for 2023-2024. That agenda would include:

- **Revamp the Website (and make it society friendly).** Initial management team: Tilman Mueller-Stoy & Georgina Busku. He said that he hoped to get this done in the next year before the Madrid Annual Meeting and to make updates that also support the local societies in some way.
- **Consider Global Organizational Memberships.** Initial management team: Emmanuel Gouge & Matteo Sabattini. He noted that this might be an area that is controversial, but something that he wanted to investigate to see wouldn't be possible for an organization to join, and such that that organization joining is that you know.
- Create a Partnership Position to Manage Business Development. Initial management team: Sonja London, Russell Levine, & Junko Sugimura. He noted the budget allocation for a business development manager to support these efforts as well as an interest in looking at possible grant proposals.
- **Create an Executive Director Review and Support Team.** He said that he wanted to provide some structure to both provide Dana Colarulli with input and support and so that he can provide the Board with input on the correct focus areas.
- **Continued Support for the Thought Leadership Program.** He said this program had been successful during the last year and he would like to further improve it and bring in more revenue to support the program.
- Rethink our Committee Support Systems. Initial Management Team: Tatiana Campello, Karin Hofmann, Ningling Wang & Keith Lutsch. This includes having the LESI committees report directly to the board and devoting the first :30 minutes or so of each board meeting to committee issues. He said that he also wanted to tie in what was happening in the local societies into the LESI committee work.

• Annual Conference in Madrid (can we get to 700?). Finally, he said he was committed to working with Jose-Miguel and the LES Spain & Portugal team to have a successful annual meeting next year.
