We met the goals for 2022-2023.

 We established and grew Industrial Advisory Board with a total of ten members from multinational companies and various national societies, including US, France, Australia & New Zealand, South Africa, Thailand, Spain, Singapore, South Korea, and Japan; and the members represent industry sectors including the mining, chemicals, materials, energy etc.

We recruited one additional member for the Industrial Advisory Board - Ms. Melody van Denzen, Senior Legal Counsel, IP of ConocoPhillips - who is a member of LES US/Canada and was kindly recommended by Karin Hoffman.

- We held quarterly teleconference calls with the Industrial Advisory Board members on June 23, 2022, September 27, 2022, and January 11, 2023; and we will have another one on April 20, 2023 (confirmed).
- We discussed the following key topics:
