1. 31 May 2022 – Webinar on Unitary Patent and Unified Patent Court

Purpose: This webinar the Unitary Patent (UP) and a patent enforcement system known as the Unified Patent Court (UPC). Discussions included the impact on patent protection, enforcement, and revocation across most of the EU member countries.

2. 6-7 October 2022 – LES Thailand Annual Conference 2022

Purpose: This two-day event was arranged under the trending subject "Living in the Future". Discussions included the topic of living in the world of technology, a metaverse and where ESG matters. On the second day, the audience explored collaboration opportunities under a newly enacted Thai ACT, Thailand Research and Innovation Utilization Promotion (TRIUP) Act B.E. 2564. This Act was drafted in line with the Bayh-Dole Act, which allowed the institutions the rights to claim title to inventions and to negotiate licensing terms that would best encourage the commercialization of technology. The audience learned about the IP valuation methods, license negotiation and Thailand and Vietnam practices on technology transfer/IP licensing in the last two sessions.
