Early Results, Feedback and Challenges

- Twenty (20) IP Owner organizations of have signed up
- Designated members = 214 and growing. 147 are new members.
- Feedback is favorable
 - Good value, Many younger members.
 - Diverse mix of operating companies, universities, non-profits and government organizations. Under consideration from many more organizations.
- The IP Owners program discounts the individual membership price of \$395 per person to \$1995 for up to 15 members.
 - LESI dues are paid for each individual.
 - We are hopeful that over the long term we are able to attract and retain a higher number of individual members through the IP Owners program, resulting in an increase in overall membership revenue.

Early Results and Feedback

- As of January, 2022, seventeen (17) young members have joined using the new Emerging Leaders program.
- Feedback is favorable
 - Good value
- We are hopeful that the reduced revenue to LES USA/CA on a per member basis in the three-year discount window will be surpassed by the long term revenue gain associated with membership maintained throughout one's career.
